Professional experience obtaining internship

1. Goals of internship

One of the educational process elements in the training of international business masters is practical training (educational internship), which strengthens and deepens the theoretical knowledge received during the training, the ability to set research goals, analyze the results and draw conclusions, as well as obtaining Professional experience.

This internship program on obtaining Professional experience of master's degree students of the program "International business In the Baltic sea region (in the English language)" is developed in accordance with the requirements laid down in the following documents:

- The Federal State Educational Standard of higher education, field of study 38.04.01 Economics (degree "Master of Economics") approved by the order of the Ministry of education and science of the Russian Federation of March 30, 2015 No. 321;

- The curriculum of master's degree student's training, field of study 38.04.01 Economics, the program "International business – business in the Baltic sea region (in the English language)".

Research area of master's degree students must correspond to the scientific field of the Chair "Global economy and international business", as well as meet the goals that have theoretical, practical, applied significance for various sectors of the economy.

In each specific case, the internship program on obtaining Professional experience and abilities gets changed and supplemented for every master's degree student, depending on the nature of the work performed.

The purpose of the internship on obtaining Professional experience is to consolidate and deepen the knowledge gained by students in the process of theoretical training, the acquisition of necessary skills of professional and practical, research and analytical activities in the field of international business management and conduct.

2. Objectives of internship

The objectives of Professional experience obtaining internship are:

- independent research activity skills development with the use of modern methods and tools of research;
- collection of the material on the topic of master's thesis;
- company's finance and economic activity matters study under the conditions of the world economy globalization;
- calculation of the economic indicators typical to a business unit activity, including foreign economic activity;
- research on a given topic, the collected information processing, analysis and understanding of the results;
- bibliographic review with the help of modern information technologies;
- skills mastering on preparing academic report on the results of the work

done, as well as the study results presentation;

- preparation of theoretical part of the master's thesis.

3. Internship place in the structure of PPEP

Professional experience obtaining internship is a part of the curriculum of master's degree students training and is a part of the variable part of the curriculum section "Practices, including research work (RW)."

Professional experience obtaining internship is based on the mastered disciplines of both the basic and the variable part of the curriculum, in particular: Microeconomics, Macroeconomics, Econometrics, Economic processes research methods, Internationalization of business, International business strategy, Financing into international companies.

Professional experience obtaining internship precedes the practice of professional skills and professional work experience obtaining and precedes pre-graduated internship.

4. Types (forms) and methods of internship

Professional experience obtaining internship is a type of educational practice of a master's degree student.

Professional experience obtaining internship is carried out in the form of an individual research project within the approved topic of scientific research in the field of study and the proposed theme of the master's thesis, taking into account the interests and possibilities of the company's departments in which it is conducted. The internship involves study of various aspects of international activities of different companies (e.g., environmental analysis and efficiency assessment).

The way of conducting the internship is a stationary one, that allows to conduct it in Pskov state University (at the graduate chair or in the scientific and educational center) or at other organization located in the city of Pskov, as well as in other regions according to the place of students' residence.

When performing the internship work students use such technologies as:

- abstract reviews;
- work with databases;
- archival materials analysis;
- views and information exchange in a virtual environment;
- field and desk research.

5. Place and time of internship.

Professional experience obtaining internship is carried out in the first year (2 semester) of master's degree training of full-time education, after completing relevant theoretical disciplines. The duration is 2 weeks (108 hours / 3 credits) in accordance with the curriculum of master's training.

Depending on the details of individual master's training, the period of Professional experience obtaining can be changed in accordance with the established procedure. The internship can be carried out at the graduate chair, in the foreign economic activity research and educational center as well as in state, municipal, public,

commercial and non-profit organizations, companies and institutions on a contractual basis, where it is possible to study and collect materials related to graduate qualification work. Preference is given to the organizations engaged in foreign economic activity.

The individual program of students' internship must be coordinated with the work plan of the base company team, meet "Master" qualification, field of study "Economics", and be determined by goals and objectives of Professional experience obtaining internship.

In the units where the internship takes place, students are given work places to perform individual tasks on the internship program.

During the internship students observe all rules of internal code of conduct and safety, established in the company and on the workplace.

6. Planned learning outcomes during the internship period correlated with the planned learning outcomes of the PPEP.

6.1. The process of Professional experience obtaining internship is aimed to develop the following competencies:

- readiness to act in non-standard situations, to bear social and ethical responsibility for the decisions made (CC-2);
- readiness for self-development, self-realization, use of creative potential (CC-3);
- the ability to generalize and critically evaluate the results obtained by domestic and foreign researchers, identify promising areas, make a research program (PC-1);
- ability to analyze and use various sources of information for economic calculations (PC-9).

6.2. Planned learning outcomes during the internship period correlated with the planned learning outcomes of the PPEP.

For competence "CC-2-readiness to act in non-standard situations, have social and ethical responsibility for the decisions made »:

As a result of passing the state exam at the competence development, student must:

- System relations in the sphere of international business, external and internal environment factors, that affect the changes in the parameters of the international business system.

7. Structure and content of internship

The total amount of Professional experience obtaining internship is 3 credits , 108 hours.

When performing the internship, an individual educational path, master's thesis subject, as well as the type of professional activity chosen by a master's degree student is considered.

The internship is done in the form of an individual independent work supervised by the research advisor and involves doing a number of tasks aimed to form the required competencies, and the task to prepare the theoretical part of master's thesis.

The following options of the internship are possible:

- direct involvement in company's activity;
- traineeship when doing analytical and / or managerial functions on the instruction of the person responsible for the practical training in the organization (curator);
- participation in research performed by the Chair "Global economy and international business" and/or by foreign economic activity research and educational center;
- other variants necessary and sufficient to achieve the objectives according to the internship goal.

The research project topic can be defined as an independent part of the research performed within the scientific field of the graduate chair "Global economy and international business".

The internship is accompanied by thematic tutorials conducted by research advisor individually with students. Tutorials are put in the order of the content, and their time limits are stipulated, as well as the materials to be submitted for verification within every tutorial.

The internship subject matter is determined by the master's program advisor on the basis of FSES HE and reflected in the work plan of the Professional experience obtaining internship, which is made as a research structure, and has the following form (appendix 1), and consists of a list of logically connected focus areas within the planned research. The research flow chart determines the completion schedule. (appendix2).

A master’s degree student makes the work plan approved by the research advisor.

The internship is organized in accordance with the logic of the master's thesis:

- thesis subject matter;
- research problem, object and subject;
- research goals and objectives;

- theoretical analysis of literature and research on the problem, selection of the necessary sources on the topic;
- reference list;
- research outcomes.

Master's degree students work with primary literature, monographs, author's abstracts and thesis research, consult their research advisors and teachers.

During the internship, students must formulate master's thesis subject in its final form on their field of study from among relevant research problems and coordinate it with the research advisor.

An important part of the internship content is the collection and processing of factual material and statistical data, analysis of relevant characteristics of the organization, where master's degree student does his practical training and intends to introduce or test the master's thesis outcomes.

Student's work when doing the internship covers several stages:

Stage 1 – Theoretical - theoretical problems study within master's training program:

- selection and justification of the research topic;
- description of the research object subject;
- scientific literature review on the research topic with the use of different methods of the access to the information: visiting libraries, Internet;
- making a list of reference on the research topic;
- research of theoretical concepts on the topic.

Stage 2 – Empirical - Study of practical activity of companies and institutions according to the master's thesis subject:

- study of the organization – place of internship (regulatory and legal, industry related, market, administrative, functional and structural, financial and business aspects of the company's activity as a whole, as well as from the point of view of international activity);
- collection and analysis of the information on the research subject in the company;
- study of individual aspects of the research subject in the company;
- statistical and mathematical processing of the information;
- research outcomes and their approval by master's thesis advisor.

Empirical research outcomes and the problems identified must be presented at a research workshop.

Stage - 3 – Final stage.

This stage is the final stage of the internship. A master student summarizes the collected materials in accordance with the internship program, identifies its sufficiency and fairness; gives forth the outcomes by writing scientific articles, organizing final workshop on the internship.

8. Internship reporting forms

The obtaining Professional experience internship reporting document is a report and a presentation of the main outcomes of the research at the graduate chair research workshop.

The head of the internship studies the report and makes a decision on the defence of the internship outcomes at the scientific final workshop. If any serious criticism on the internship report, students must eliminate all shortcomings and submit the report for a check-over. Students prepare the presentation independently and are solely responsible for any shortcomings both in the report and in the electronic illustration.

Also at this stage, the topic of the research thesis is specified for its further development within the practical training in the second academic year.

The report on the internship, the presentation (report and electronic illustration) of the internship outcomes, as well as the topic of the final qualification work (master's thesis) are formulated entirely in English.

The report on the internship, signed by the research advisor, is submitted to the master's program advisor (Appendix 3).

9. Midterm assessment forms (based on the internship outcomes)

The assessment of the outcomes of Professional experience obtaining internship is carried out on the basis of public defence of the research major outcomes at the final research workshop at the graduate chair. The internship outcomes defence involves:

- a report with e-presentation on the internship main outcomes;
- internship report signed by the head of the internship;
- comments by the head of the internship and the internship mentor from the company- place of the internship (if any);
- answers to the workshop participants' questions.

Internship reports are submitted in writing to be checked by the master's thesis research advisor. To obtain a positive assessment, students must fully complete the internship program, timely draw up all kinds of necessary documents and pass through public defence.

Following the results of the positive assessment, students are given a graded mark (excellent, good, satisfactory).

An internship grade is equal to grades in theoretical disciplines and is taken into account when making the results of a midterm assessment.

According to the results of Professional experience obtaining internship, students finalize their articles to be published, make up their speeches at scientific and practical conferences and workshops.

Failure to submit a report, as well as obtaining an unsatisfactory mark on the internship outcomes defence means a failure of the training program completing, it is considered an academic failure that must be liquidated to get admission to the master's thesis defense.

7. Characteristics of the knowledge level of the master's thesis.
8. Characteristics of key terms on the topic of the master's thesis.
9. Characteristics of the empirical base of the research on the topic of the master's thesis in the organization - the place of internship.
10. Characteristics of the main hypothesis of the research on the master's thesis.

11. Academic support for students' independent work during the internship.

Supervision and control over the internship are imposed on the research advisors of master's degree students in the corresponding field of study.

The general academic internship supervision is carried out at the graduate chair "World economy and international business".

Research advisor renders organizational and methodological assistance to the master student to solve the research problems.

Research adviser:

- coordinates the internship program and the research project topic with the master student;
- organizes necessary arrangements to carry out the internship program;
- outlines the overall scheme of the research, the schedule of the internship, the student's working time hours and takes charge of the internship progress and the students' work;
- sets tasks and goals for independent students' work during the internship giving an individual task to collect necessary materials for the master's thesis, consults students;
- gives recommendations on professional literature and research methods;
- participates at the final workshop.

When doing the internship on obtaining Professional experience on a contractual basis in the state, municipal, public, commercial and non-commercial organizations, companies and institutions performing foreign economic activity, a **base internship mentor** is appointed in this organization.

Base internship mentor:

- informs his master student about the internal rules and regulations, safety measures,
- provides a workplace to the master student;
- organizes access to the basic data of the object, the subject of the research;
- coordinates the individual student's working program with the work plan of the internship base team.

At the end of the internship, the mentor makes a report (appendix 4).

During the internship, a master student gets instructions, recommendations and explanations from his internship advisor on all matters related to the internship, reports on the work performed in accordance with the schedule of the internship..

Master's degree student:

- carries out the research on the approved topic in accordance with the schedule of the

internship and the operating schedule of the company - the internship place ;
- gets instructions, recommendations and explanations on all matters related to the internship from his advisor;

- reports on the work performed in accordance with the established schedule.

During the internship , students must do all the tasks written in their individual internship plans and submit a report. The internship outcomes are reflected in the internship report on Professional experience obtaining. The report must have the outcomes of the work as written in the individual work plan.

Requirements for the report:

-title page must be arranged in accordance with the requirements in Russian and English;

- the text of the report (in English) must be structured, the names of sections and subsections must be numbered and have numbers of the pages they begin with;

- numbering of pages , tables and appendixes must be consecutive.

The internship report consists of :

1) Title page (Appendix 3).

2) Individual work plan of the internship (Appendix 1).

3) Report content with numbering of sections and subsections, pages.

4) Introduction – goals and objectives the author sets and solves during the internship and presents them in the report.

5) Chapter 1 - applied research in the following areas:

- familiarization with the activity of the enterprise (organization), product nomenclature , including exports and imports, specifics of foreign economic activity of the enterprise;

- study of the organizational and functional structure of the enterprise, the specialization of the units and the conditions for their interaction on the matters of foreign economic activity;

- study of the business administration of the enterprise and the unit responsible for foreign economic activity;

- study of the specifics of foreign trade contract prices and the practice of drawing up foreign trade contracts;

- study of the content and methods of planning the work of the enterprise as a whole and structural units that carry out foreign economic activity;

- calculation and analysis of financial and economic indicators of the enterprise, proposals drafting aimed to improve the efficiency of the enterprise, including that in the foreign market.

6)Chapter 2 - description of the research carried out on the proposed topic of the master's thesis, the outcomes obtained, the problems identified. The data must be structured, presented in the form of tables, figures with necessary explanations.

7)Conclusion - it is necessary to give major conclusions obtained during the research, describe the limitations and prospects to continue the research topic;

8) List of used literature sources (made in accordance with GOST).

9)Appendixes.

Presentation of the research major outcomes at the research workshop at the graduate chair must meet the following requirements:

- presentation language - English;
- report - 7 minutes at most;
- electronic pictures and graphics of the presentation must be done using: Microsoft Power Point, Google Presentation or others.

13. Internship material and technical support

14. Special aspects of the organization of the internship for the disabled and persons with disabilities

PPEP provides a possibility to teach the disabled and persons with disabilities.

The internship assignment for the disabled and persons with disabilities is developed individually, coordinated with the students, the PPEP director and a representative of a possible employer.

When choosing the internship base, recommendations of medical and social expertise on the possible conditions and types of work for students are taken into account. Based on the student's personal application, the internship (individual stages of the internship) can be carried out according to the established procedure.

For the disabled and persons with disabilities, the selection of the internship place is coordinated with the requirement of their accessibility for the student, and the possibility to receive, transfer and exchange information in an intelligible form is foreseen.

E-agreement with the internship base, followed by the original agreements in the midterm assessment period is assumed.

Internship conditions for the disabled and persons with disabilities with due regard to

professional activity type and the nature of the job functions of students must be provided at the company (organization) – the internship base.

The internship assignment is developed individually with the participation of a representative from the internship base and the student taking into account the peculiarities of the internship base and the student’s health conditions.

The internship assignment scope and content, the internship report are determined individually.

The internship midterm assessment of the disabled and persons with disabilities is carried out in the established form, on the basis of the written report and the comments by the internship advisor, in the intelligible form for students.
